A BYLAW OF THE TOWN OF WADENA TO CONTROL THE USE OF WATER  
FROM THE MUNICIPAL WATER SYSTEM.

THE COUNCIL FOR THE TOWN OF WADENA, IN THE PROVINCE OF  
SASKATCHEWAN, ENACTS AS FOLLOWS:

1. THIS Bylaw may be cited as the "Water Restriction Bylaw".
2. PURSUANT to Section 184 of *The Urban Municipality Act, 1984* watering of lawns and gardens shall be restricted as follows:
  - a) Subject to clause (c) Residential, Commercial, Industrial and Institutional properties with an even numbered civic address shall water on even numbered calendar days between the hours of 8:00 p.m. and 11:00 p.m. only.
  - b) Subject to clause (c) Residential, Commercial, Industrial and Institutional properties with an odd numbered civic address shall water on odd numbered calendar days between the hours of 8:00 p.m. and 11:00 p.m. only.
  - c) No lawns or gardens shall be watered on Mondays.
3. PURSUANT to Section 184 of *The Urban Municipality Act, 1984* Council for the Town of Wadena may limit or restrict completely the amount of water supplied to any or all consumers should circumstances warrant such action.
4. THE provision of this bylaw shall apply and remain in force, as determined by Wadena Town Council, for the months of May, June, July, August and September of each year.
5. A property may be granted an exemption from the provisions of this bylaw for the purpose of watering a newly planted lawn. An application for the exemption is to be made to the Town of Wadena stating the reason for the application, civic address of the property to be affected and date of commencement of the exemption. Exemption shall only be granted for a period of 30 days.
6. ANY person who contravenes any of the provisions of this bylaw or neglects or refuses to comply therewith shall be liable to the following penalties:
  - a) First Offence - Written warning by registered mail or by personal service of a Notice of Violation.
  - b) Second Offence – Twenty-Five Dollar (\$25.00) Fine.
  - c) Third and Subsequent Offences – Fifty Dollar (\$50.00) Fine and termination of water service for a period of Twenty-Four (24) hours.
